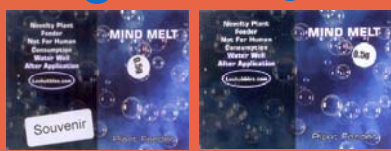

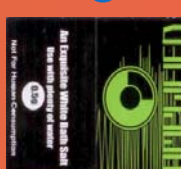
Note: Offered for sale as a 'herbal snuff'. A sample of Pure NRG purchased on 13/06/10 was found to contain caffeine and naphyrone.



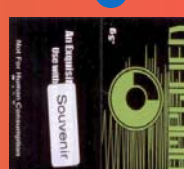

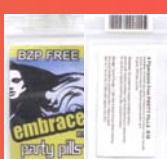

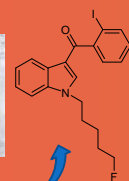

Note: The EI mass spectra of dimethylcathinone (metamfepramone) and ethcathinone are very similar. Dimethylcathinone is also known as dimethocaine which can easily be confused with dimethocaine.

These are the active constituents identified to date. Analysis is on-going.

On a general note, by monitoring websites offering 'research chemicals' for sale, we have observed that MDAT, MDAI, 5-IAI and especially 6-APB ('Benzo Fury') are becoming quite popular. However, the actual availability of 'Benzo Fury' from such websites is unclear and some state that the 'official launch date' is the beginning of August.
